Burns, et al, recorded in Volume 1362, Page 710 of the Official Records of Grimes County, Texas, said 2.00 acres being more particularly described by metes and bounds as follows;

BEGINNING at a 1/2 inch iron rod found at the most westerly corner of said 12.755 acre tract, located at the northwest corner of a called 2.00 acre tract to Jeanie I. Burns, et al, (Tract One - 1362/710), also located on the east margin of Piedmont Road, for the northwest corner of this;

THENCE along the west line of said 12.755 acre tract, with the east margin of said road N 30°52'06" E a distance of 306.60 feet to a 1/2 inch iron rod with yellow cap set for the northwest corner of this, located at the southwest corner of a called 10.07 acre tract to Muriel M. Bingham, (220/80), from which a found 1/2 inch iron rod with orange cap bears N 51°32'32" W a distance of 5.55 feet;

THENCE along the northeast line of said 12.755 acre tract, common boundary with said 10.07 acre tract S 55°44'06" E a distance of 1171.11 feet to a 1/2 inch iron rod with yellow cap set at the most easterly corner of said 12.755 acre tract, located at the northwest corner of a called 2.284 acre tract to the City of Navasota, (640/843), for the most easterly corner of this

THENCE along the southeast line of said 12.755 acre tract, common boundary with said 2.284 acre tract S 39°24'56" W a distance of 806.47 feet to a 1/2 inch iron rod found at the south corner of said 12.755 acre tract, located at the most westerly corner of said 2.284 acre tract, also located on the northeast line of a called 1.665 acre tract to John Hueske and Tracey Hueske, (1343/779), for the south corner of this;

THENCE along the southwest line of said 12.755 acre tract, common boundary with said 1.665 acre tract and the remainder of a called 5.15 acre tract to Indalecio M. Garcia and Frances A. Garcia, (845/437) and generally along a fence line N 39°13'29" W a distance of 525.70 feet to a 1/2 inch iron rod found at a northwesterly corner of said 12.755 acre tract, located at the south corner of a called 1.999 acre tract to Karina C. Villasenor and Victor M. Villasenor, (1729/204), for a northwesterly corner of this;

THENCE along the west line of said 12.755 acre tract, common boundary with said 1.999 acre tract and generally along a fence line N 30°06'06" E a distance of 240.11 feet to a 1/2 inch iron rod found at a northwesterly corner of said 12.755 acre tract, located at the most easterly corner of said 1.999 acre tract, also located on the southwest line of said 2.00 acre tract, for a northwesterly corner of this;

THENCE continuing along the west line of said 12.755 acre tract, common boundary with said 2.00 acre tract, the following courses and distances:

S 56°30'09" E a distance of 70.49 feet to a 1/2 inch iron rod found for an interior corner of this; N 30°04'37" E a distance of 162.56 feet to a 1/2 inch iron rod found for an interior corner of this, and N 60°48'11" W a distance of 620.12 feet to the **POINT OF BEGINNING**.



BEGINNING at a 1/2 inch iron rod found at the northwest corner of said 2.00 acre tract, located at the most westerly southwest corner of a called 12.755 acre tract to Jeanie I. Burns, et al. (Tract Two -1362/710), also located on the east margin of Piedmont Road, for the northwest corner of this;

THENCE along the north line of said 2.00 acre tract, common boundary with said 12.755 acre tract S 60°48'11" E a distance of 620.12 feet to a 1/2 inch iron rod found at the northeast corner of said 2.00 acre tract, being an interior corner of said 12.755 acre tract, for the northeast corner of this;

THENCE along the east line of said 2.00 acre tract, continuing with said 12.755 acre tract, S 30°04'37" W a distance of 162.56 feet to a 1/2 inch iron rod found at the southeast corner of said 2.00 acre tract, being an interior corner of said 12.755 acre tract, for the southeast corner of this;
